### Color Usage |

The Brand colors should be used on all signage and communications. It will give a consistent look and feel to the store and create a more recognizable and memorable experience for the Roses shopper.

#### Using the colors |

The base color is blue and most communication should use the assortment of blues for the base. The scale above is a visual guide to estimate how much of each color should be used.

#### Highlight and call out colors |

If you wish to have an attention grabbing call out on either in store signage or for print based items, the Roses yellows should be used as the base colors. This will highlight the selected call out and keep within the brand colors. This should be limited to about 10% of signage or call outs. Limiting the volume of material that uses yellow as the base color will allow that communication to truly stand out.
